## Parent's Statement of Agreement

### I understand and agree to the following conditions of admission:

1. Christian education is a cooperative undertaking among the school, parents and students. Consequently, the educational philosophy, objectives and policies of the school will receive my support and that of my child at and away from school. The lack of such support will be grounds for not being permitted to reenroll and in extreme cases, for dismissal from school according to school policies.

2. Desiring my child's total education program to be effective, I agree that I will maintain for my child an environment away from school which is compatible with the school, especially in the area of moral standards.

3. I understand that if my child possesses or uses alcoholic beverages, illegal drugs or tobacco products at or away from school, he or she will be dismissed from school or subjected to other disciplinary measures at the discretion of the administration.

4. I have carefully examined and endorsed the Mission Statement and Faith Statement of Hebron Christian Academy, as stated on our website and Parent/Student Handbook, and desire the school to work with me in the total education of my child.

5. If for any reason my child does not meet the academic requirements or cooperate with the disciplinary standards in accordance with the procedures stated in the Parent/Student Handbook, I will cooperate with the administration as it handles these situations and will avoid discussion with those not involved, so as to avert a spirit of dissension and division at either my child's expense or the school's. HCA reserves the right to dismiss, suspend, or otherwise discipline any student who does not adhere to the standards stated in the Parent/Student Handbook.

6. In case of accident or serious illness, I request the school to contact me. If the school is unable to reach me, I give the school my permission to administer minor first aid to my child if they deem necessary. If further emergency treatment is necessary, I grant permission for the proper school authority to make arrangements for this treatment. I understand that all charges for such treatment are my responsibility to pay. I agree to release and hold harmless, the school and its employees from all claims, damages or other liabilities for injuries to my child which are not the result of gross negligence by this school or employees. I also agree to indemnify the school for damages by my child.

7. I grant permission for my child to go on trips authorized by the school with his or her classmates and to participate in school activities, including extra-curricular activities, both at and away from school.

8. I grant permission for photographic images taken of our family members to be used in school newsletters, the school website, the school yearbook, advertisements, annuals and other promotional material. Also to include my child's name in connection with news articles pertaining to school programs and all activities. I grant permission for my name, address, phone number and student data to be listed on Renweb and available for viewing.

9. I agree to support my child in upholding the HCA Honor Code: "Because I desire to hold myself and others to the standard of God's Word, I commit to a lifestyle that upholds integrity, grace, and respect toward my peers and authority. I will not stand for lying, cheating, stealing, discrimination, or other dishonorable behavior. As a member of the HCA community, I acknowledge that this lifestyle requires accountability and dependence upon others and Jesus Christ."

10. I understand that new students are admitted under academic and behavioral probation for one semester after which the administration will review the student for elimination of probation, extension of probation, or dismissal.
